

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.absolutegenomic.com, and Absolute Genomics PHL LLC and governs data collection and usage. Collection of your Personal Information

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services.
